Elmer Kelton to Speak April 21

Award-winning Texas author Elemer Kelton will be the featured speaker at the Eules Library Foundation's 2007 Fundraiser on April 21, 2007.

Kelton is the author of over 40 novels in his more than 50 year publishing career. Three of Kelton's novels have appeared in Reader's Digest Condensed Books. Four books have won the Western Heritage Award from the National Cowboy Hall of Fame, Oklahoma City; seven have won the Spur award from Western Writers of America.



In 1987 he received the Barbara McCombs/Lon Tinkle Award for "continuing excellence in Texas letters" from the Texas Institute of Letters. In 1990 he received the Distinguished Achievement Award from the Western Literature Association.

His latest novel is "Brush Country."

Tickets are \$35 per person and include a barbeque dinner. Seating is limited so make your reservations early. Tickets will be available at the Eules Public Library after March 1 and must be purchased by April 16.
